

Benefit Enrollment Assistance Program

Several State and Local agencies have programs to help people meet the costs of their housing, food, and healthcare needs. The Lord's Pantry now has a program to assist you to find out if you qualify for some of these programs and help you apply online for the benefits.

The benefits* covered in our program are:

SNAP (Food Stamps)

Women's, Infants, and Children Nutritional Program (WIC)

Primary medical and dental care (Community Volunteers in Medicine)

Children's Health Insurance Program (CHIP)

Temporary Assistance for Needy Families (TANF)

Medicaid (Medical Assistance)

Rental Assistance (Housing Assistance Corp of Chester Co)

Low Income Home Energy Assistance Program (LIHEAP)

PA Property Tax or Rent Rebate

Here's how it works: The Pantry uses the state's free, confidential on-line program to determine who is eligible for benefits and to fill out the applications. After you make an appointment, a Pantry volunteer will walk you through the process, as you answer questions about members of the household. One application covers all the benefit programs.

You'll need to bring the following information with you, if applicable:

- **Income amounts for your entire household before taxes** - this includes income from a job and all other forms of income (social security, pension, workers' comp, unemployment, child support, etc)
- **Proof of citizenship and identity if you are a US citizen** - Birth Certificate; Driver's License; State ID
- **Social Security Numbers and birthdates** for all household members
- **Day care expenses** for your household (if any)
- **Work transportation expenses** for your household (if any)
- **Current or recent health insurance information** (from the last six months)
- **Housing and utility expense information**
- **Real Estate Tax Bills** (if applying for tax rebate)
- **Resource information**, such as bank accounts, vehicles, homes, property, life insurance, etc. Note: Resource questions will only be asked if this information is needed for a particular program.
